## SUNAUTO - FUGETRADING S.L.

# **LEASE TERMS**

#### I. CAR OPERATION

The car may only be driven on official paved roads. Use of the car on other types of / unpaved roads is strictly prohibited and is not covered by all insurance coverage.

The renter can only add pre-agreed additional drivers to the lease.

All drivers must be 26 years of age or older and have a driver's license at least one year old.

The car may only be driven on Spanish territory unless SUNAUTO has given written permission to use the car outside Spanish borders. When the car is parked, make sure that the car is locked and the windows are closed, and no objects should be left in the car if the car radio has a removable panel, it must be removed and hidden. The roof of the convertible must always be closed when the car is parked.

The car must be returned with at least the same amount of fuel as when handed over. If the car is returned with a smaller amount of fuel, SUNAUTO will charge the missing fuel and a refueling fee of 2O euros.

#### 2. LIABILITY FOR THE CAR AND ITS EQUIPMENT DURING THE RENTAL PERIOD

The renter's basic deductible is € 350, the renter is obliged to compensate up to the upper limit of the deductible:

- (a) any significant damage to the car and its equipment.
  - (b) any stolen parts of the car or its equipment.

The lessee may be obliged to compensate in addition to the deductible:

- key loss / damage.

damage to the car due to the use of the wrong fuel.

If the damage caused to the car or SUNAUTO is the result of the renter's intent, use of the car under the influence of alcohol or other drugs or for criminal purposes, the renter is obliged to compensate SUNAUTO in full.

#### 3. LESSEE'S EXEMPTION FROM LIABILITY

The lessee is released from the liability for the deductible if SUNAUTO receives full compensation for the damage on the basis of the insurance or from the person who caused the damage.

#### 4. FINE

The renter is obliged to pay the fines, parking and parking error fees incurred during the rental period, including for additional drivers. SUNAUTO may charge these fees in arrears to the tenant's credit card. SUNAUTO charges a € 30 fine for handling / office fines.

#### 5. LESSEE'S MEASURES IN THE EVENT OF INJURY

In the event of a traffic accident, the renter is always obliged to report the damage to the rental company without delay. The report is made using the damage report form in the glove compartment of the car. The damage report form should be filled accurately and completely by both parties, including witnesses (if any), and draw the image properly, clearly signifying the party that has caused the damage. In case of personal injury or the question of guilt is unclear, the police must always be called to the scene.

SUNAUTO charges a lessee deductible amount each time, and return it if the other party receives compensation from the insurance company.

The renter must immediately notify SUNAUTO of any defect, damage or theft in the car.

The theft must be reported to the police without delay and a copy of the theft report (denuncia) must be sent to SUNAUTO. If the renter fails to make the above notifications, he will be liable to the rental company for any damages incurred.

### 6. CAR RETURN

The car will be returned to the agreed place at the end of the rental period, a change in the return time and place must be agreed with SUNAUTO.

#### 7. RENTAL PERIOD

The rental day is 24 hours. The full price for the next 1 day may be charged for the excess hour.
